Submissions to the Royal Commission now available

The Royal Commission into the Protection and Detention of Children in the Northern Territory has today published 62 formal submissions received from 59 organisations, peak bodies, academics as well as Non-Government bodies.

These submissions are now available on the Royal Commission website.

More than 320 submissions were received by the Commission and these will continue to be published with consent on an ongoing basis.

Since its inception on 1st August 2016, the Commission has encouraged submissions from across the community to ensure a full and accurate understanding of issues affecting children in the protection and detention in the Northern Territory.

Kirsty Windeyer, Official Secretary for the Royal Commission thanked the individuals and organisations who have taken the time to write and lodge submissions.

"Submissions are one of the important ways the Commission collects information and the contribution of so many individuals and organisations is greatly valued.

"These submissions have helped us understand the issues in child protection and youth detention in the Northern Territory and are of assistance as the Royal Commission formulates recommendations for the future.

"They are an incredibly valuable body of work and I would like to thank all those who took the time to make their views known to the Commission", said Ms Windeyer.

Non Publication Direction in respect of Notices of Adverse Material

The Royal Commission has issued an updated <u>Non Publication Direction</u> in respect of Notices of Adverse Material.



The Non Publication Direction applies to a Notice of Adverse Material and the information in the notice. It applies to the person who receives the notice as well as any person who becomes aware of a notice or its content. The provision or publication of an adverse notice or its content other than as allowed by the Non Publication Direction is a breach of that direction.

The purpose of giving draft material and findings to relevant parties is to ensure that they have the opportunity to respond to adverse material. The Commission will review all responses and will then finalise its findings.
